A. INTRODUCTION:

Applications are invited from eligible candidates for the following Para Medical & Allied Medical Science courses in Government and Govt. approved Private institutions of State. Alllatest information related to counseling and admission will be available on DMET's official website (www.dmetodisha.gov.in) only.

Candidates desirous of taking admission in the Master's Degree courses have to apply to State Govt. approved institutions directly through "offline" mode only. State Government approved institutions are to counsel the eligible candidates at their end and submit the data through "online" on the Combined Paramedical Counseling portal and the verified original documents of the candidates are to be approved by the Convener, Selection Committee as per schedule. - b. The Convener is authorized to float advertisements, convene meetings, and conduct selection and allotment of seats strictly as per the guidelines. He/ She is the custodian of all documents including vouchers of expenditure of counselling process and will produce them as and when required within the weeding out period. The expenditures will be made as per approved guidelinesofGovt.He/Sheisauthorizedtofileaffidavitsinalllegalmatters,onbehalfoftheState Respondents. To facilitate the work one Programme Assistant, one Data Assistant and one Gr D staff shall be temporarily engaged on out source basis and the expenditures shall be met from the application/ counseling fees.
- c. Sub-committees shall be formed by the Chairman to manage different works.
- d. Selection Committee reserves the right to withdraw the name of the candidate from the state merit list, if any, placed in advertently, who is not eligible to be placed in the state merit list due to any reason.
- e. In case of any ambiguity in interpretation of any of the instructions / terms / rules / criteria regarding determination of eligibility / registration of candidates / conduct of counselling / information contained in the guidelines, the decision of the committee shall be final and binding.

Lateral Entry to second year Degree, Diploma and Certificate courses shall be permissible up to maximum of 10 % of the "approved intake" which shall be over and above, supernumerary to the "approved intake", plus the unfilled vacancies of the First year.

- 1. Must be of 17years of age as on 31StDecember, 2025 and there will be no upper age limit.
- 2. The candidate must be a permanent resident of Odisha.

<u>OR</u>

Son, daughter or spouses of:

- i) Employee of Govt. of Odisha.
- ii) Defense Personnel posted in Odisha/ Employee of Govt. Of India working in Odisha.
- iii) Member of All India Services (Odisha Cadre) serving within/outside Odisha
- iv) Employee of Govt. of India Undertaking/Govt. of Odisha Undertaking located in Odisha. Such claims should be supported by certificate of service of parents or spouse from competent Authority.

<u>OR</u>

Odia belonging to outlying Odia speaking tracks (as defined by Government of Odisha, P.&S. Dept., Resolution No.13411 Gen. dated 8.8.69, as amended from time to time). Such candidates must have Odia as M.I.L in H.S.C. or equivalent examination and shall furnish the certificate of authenticity of their domicile from appropriate authority of the locality or H.S.C. certificate showing Odia as M.I.L.

<u>OR</u>

admission into Private Colleges only & not Government College, subject to condition that, their cases would be considered after all candidates belonging to above are exhausted.

NB: In case of equivalent examinations, the equivalency certificate from Council of Higher Secondary Education (CHSE) must be submitted by the candidate. Where a consolidated list of such equivalent examinations has already been notified by the CHSE and the name of the Board is in the list, the submission of equivalency certificate will not be required. However the institutions shall obtain the authenticity of the mark sheet and pass certificates and submit at he time of form fill up in the Board failing which the candidature will be rejected and action as deemed fit shall be initiated.

Note:

- i. Scheduled Caste / Scheduled Tribe persons who have migrated from the State of origin to some other State for the purpose of seeking education will be deemed to be Scheduled Caste/Tribe of the State of their origin and will be entitled to derive benefits of reservation from the State of origin and not from the State to which they have migrated. (Vide Govt. of India letter No. BC/16014.1.82-SC & BCD/dated 22nd Feb.1985.
- ii. In case of non-availability of candidates belonging to any reserved category, the unfilled seats will be filled up by the UR candidates. Inter-changeability between the SC & ST is not allowed.
- iii. Five percent (5%) seats of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act,2016 (the details is as per **Annexure—A**). This will be decided by a Medical Board and candidates seeking admission under this category shall appear before a Medical Board to be notified later.
- iv. There is no reservation category for any course under Lateral Entry scheme.

I. PROCEDUREOFAPPLICATION

Eligible candidates shall apply online in the website of DMET Odisha. They have to deposit an application fee of **Rs. 600/- per course**, online at **State Bank Collect** [under Odisha/ Govt. Department/ **Combined Paramedical Counseling, DMET Odisha**, / Counseling Fee]. The application fee

is not refundable. They have to attend the document verification as per schedule date which will be notified in the website and submit a print copy of online application, a copy of the bank transaction receipt, and photocopy of required documents. They must bring the original documents for verification. After successful verification of the documents merit list shall be prepared and notified in the website. Any other information if required shall be notified by the Convener in the website of DMET, Odisha i.e. www.dmetodisha.gov.in.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

Candidates have to lock their choice of subject and institution online on the schedule dates or as may be notified by authority.

College and course will be allotted on merit basis. The candidate can download the allotment cum admission letter and personally appear before the Convener on the notified date, time and venue along with required admission fees for provisional admission. The mode of deposit of admission fees will be notified by Convener. The candidate has to deposit the original College Leaving Certificate / School Leaving Certificate as the case may be and will be issued a provisional admission letter.

The candidate must report before the authority of the institution allotted with in stipulated date as notified and submit a copy of the provisional admission letter for completion of admission process at institutional level.

J. PROCEDURE OF SELECTION

Merit list shall be prepared on the basis of percentage of marks secured asunder:

For Direct Entry:-

Courses from Sl.No.1 to Sl.No.24- Total percentage of marks secured in Physics,

Chemistry and Biology/Mathematics (whichever is

more).

Courses from Sl.No.25 to Sl.No.27- Total percentage of marks secured in HSC.

Resolving Tie: In case of tie, it shall be resolved in the following order:

- i. the candidates secured more marks in total marks at + 2 level.
- ii. the candidates secured more mark in Biology/Mathematics at +2 level.
- iii. the candidates secured more mark in Chemistry at +2 level
- iv. the candidates older in age

For Lateral Entry:-

Courses from Sl. No. 1 to Sl. No. 2 - Total percentage of marks secured in Diploma

Courses from Sl. No. 3 to Sl. No. 4 - Total percentage of marks secured in ANM

Allotment of seat will be on the basis of merit and choice in online mode. Allotment list shall be uploaded in the website of DMET, Odisha, i.e. <u>www.dmetodisha.gov.in</u>

If at the end of counselling vacancy still exists due to any reason the convener may notify a spot counselling. Physical presence of the candidate is a must for participating the spot counselling. The process of spot counselling shall be as under:

- 1. The CLC and the admission fees are mandatory failing which no admission will be given and the next candidate in merit will be admitted. The details regarding deposit of fees shall be notified by Convener in due time.
- 2. The candidates who have already taken admission in earlier rounds of counselling and have submitted CLC and admission fees are required to deposit differential fees or will get a refund of differential fees if any (i.e. if changing the admission between a Govt. and private college)
- 3. Unfilled seats in reserve category shall be filled up by General candidates.
- 4. Candidate once admitted in a seat in spot round is final and are not allowed to change the seat/subject. However candidates once admitted can leave the seat by submitting resignation to concerned Principal of the institution before the last date notified by the Convener.

Other procedures detail & schedules of different rounds of counseling, choice locking, schedule of provisional admission & reporting etc. related to online counseling will be notified by the Convener in the web site of DMET, Odisha in appropriate section as and when required. Candidates are requested to be in constant touch with the website.

The Selection Committee shall conduct the counselling for all the seats of Govt. institutions and 85% seats of the private institutions. The rest 15% seats of the private institutions shall be filled up by the Institutions as management quota. After completion of the counselling if any state quota seat of private institution remains unfilled then it shall be deemed to be surrendered to the concerned institution and shall be filled up at the level of the institutions. The institutions have to make online entry of admitted students through management quota and intimate the Convener regarding the details of such admissions at their level within one month after the completion of state counselling. **No further admission after this shall be allowed under any circumstances**. The institution shall place the documents of the admitted candidates before the Convener for verification and deposit the application fee of Rs. 600/- per candidate through SB Collect.

L. ADMISSION:

- i. On selection admission shall be done before the Convener on deposition of original CLC and the admission fees. Such fees and certificates shall be transmitted to the concerned institutions (only for the candidates reported at the allotted institution) along with the list of names of admitted candidates in due course of time.
- ii. If a candidate surrenders a seat before the last date of counselling they will be eligible for refund of their 90% of fees deposited and 10% will be retained as processing cost. No refund shall be made for surrender / resignation after the counselling is over. When the candidate has deposited counselling fees in central counselling and did not get admission then he will be exempted for fee for verification of documents in management quota admissions.
- iii. After commencement of session no migration or change of institutions shall be allowed.

N. DOCUMENTS TO BE SUBMITTED DURING DOCUMENT VERIFICATION.

The following original certificates along with clear self-attested photocopy (both sides of the document to be photocopied) should be produced before the Convener for verification.

- (i) Passcertificate of H.S.C. or equivalent examination with M.I.L. and date of birth of candidate recorded therein (if the D.O.B./subjects is not written in the H.S.C. Certificate but appears on the Admit Card/Mark-sheet then the same is to be enclosed). Other certificates of age such as Certificate from Headmaster/Principal of the School/College, birth certificate from hospital or municipality etc. are not acceptable.
- (ii) Pass certificate of the qualifying examination showing the subjects studied.
- (iii) Mark-list of the qualifying examination.
- (iv) Conduct certificate from the Principal of the College last studied/gazette officer (issued within last 6 months).
- (v) Caste/Tribe Certificate from appropriate authority.
- (vi) Physically Handicapped certificate issued by SSPED Department, Govt. of Odisha is accepted through on-line. (Certificate issued by any other mode will not be accepted).
- (vii) Green Card(all pages) issued by the CDM & PHO of the concerned District in case of candidate claiming the seat reserved for children of "Green Card Holders". The name, father's name & date of birth of the beneficiary must have been mentioned clearly on this certificate and should tally with the data mentioned in the High School certificate(If any discrepancy found, then the GC facility will not be available). This facility of the green card must not have been used before by the same candidate.
- (viii) Certificate in the prescribed format from the Station Commander/Officer Commanding/Office-in-charge in case of candidate claiming seats reserved for children of Defence personnel or Certificate in the prescribed format from the Zilla/ Rajya Sainik Board in case of candidate claiming seats reserved for children of Ex-servicemen.
- (ix) Residential/Nativity Certificate issued by appropriate authority, issued within five years.

 OR Service Certificate of parent/ spouse. In case no such certificate obtained by the candidate, HSC or equivalence certificate issued by the competent board will be considered subject to condition that for eligibility under state category the local address of the educational institution will be treated as his place of residence.
- (x) The Online Bank deposit receipt of application fee.

O. PROHIBITION OF RAGGING IN EDUCATIONAL INSTITUTION:

Ragging is totally banned & prohibited in all the institutions. Anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished including cancellation of admission, Expulsion /Rustication from the College with debarring from admission to any other College and fine ranging from Rs.25,000/- to Rs.1,00,000/-shall be imposed. Q. MISCELLANEOUS

- a. In all matters relating to eligibility or otherwise of a candidate for undergoing training the decision of the Chairman Selection Committee shall be final.
- b. No stipend will be paid during the training period.
- c. The candidates are to abide by the rules and regulations of the institution.
- d. During traininghours private practice or job of any kind is strictly prohibited. If anybody is found to be indulged in such activities, the admission will be cancelled and legal action as deemed proper will be taken against him/her.
- e. No candidate is allowed to pursue two courses simultaneously.
- f. Spot round counseling is not mandatory and may be done only if vacancy exists and the Selection Committee decides.
- g. Inter-college transfer is not allowed after the admission is completed. Change of course or college is only possible during counseling process by locking the choices or manually during a spot counseling.
- h. Any corrigendum or addendum issued by the Chairman shall be a part of the advertisement.

GUIDELINESFORDISABILITY

ASCHEDULEisannexedregarding, "SPECIFIEDDISABILITY" clause(zc) of section 2, that states as under,

1. Physical disability

A. Loco motor disability (a person's inability to execute distinctive activities associated with movement of self andobjects resulting from affliction of musculoskeletal or nervous system or both), including—

- (a) "leprosy cured person" means a person who has been cured of leprosy but is suffering from— (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity; (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity; (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- (b) "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specificare as of the brain, usually occurring before, during or shortly after birth;
- (c) "dwarfism" means a medical organization resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- (d) "muscular dystrophy" means a groupof hereditary genetic muscle disease that weakensthe muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;
- (e) "acid attackvictims" meansaperson disfigured due to violent assaults by throwing of acid or similar corrosive substance.

B. Visual impairment—

- (a) "blindness" means a condition where a person has any of the following conditions, afterbest correction— (i) total absence of sight; or (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or (iii) limitation of the field of vision subtending an angle of less than 10 degree.
- (b) "low-vision" means a condition where a person has any of the following conditions, namely:—(i)visualacuitynotexceeding6/18orlessthan20/60upto3/60orupto10/200(Snellen) inthebettereyewithbestpossiblecorrections;or(ii)limitationofthefieldofvisionsubtendingan angle of less than 40 degree up to 10 degree.

C. Hearingimpairment-

- (a) "deaf"meanspersonshaving 70DBhearingloss inspeechfrequenciesinbothears;
- (b) "hardofhearing" meansperson having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
- D. "speech and language disability" means a permanent disability arising out of conditions such as laryngectomyoraphasiaaffectingoneormorecomponentsofspeechandlanguageduetoorganic or neurological causes.
- Intellectual disability, a condition characterized by significant limitation both in intellectual functioning (reasoning,learning,problemsolving)andinadaptivebehaviorwhichcoversarangeofeveryday,social and practical skills, including—
 - (a) "specific learning disabilities" means a heterogeneous group of conditions wherein there isa deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditionsasperceptualdisabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
 - (b) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand

relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

- 3. Mental behaviour,— "mental illness" means a substantial disorder of thinking, mood, perception, orientationormemorythatgrosslyimpairsjudgment, behaviour, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by sub normality of intelligence.
- 4. Disability caused due to—
 - (a) chronic neurological conditions, such as— (i) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other; (ii) "parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.
 - (b) Blooddisorder—
 - (i) "haemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
 - (ii) "thalassemia" meansagroup of inherited disorders characterized by reduced or absent amounts of haemoglobin.
 - (iii) "sickle cell disease" means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of hemoglobin.
- 5. MultipleDisabilities(morethanoneoftheabovespecifieddisabilities)includingdeafblindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
- 6. Anyothercategoryasmaybenotifiedbythe CentralGovernment.
