## Instructions to apply for BMLT/BMRT Courses for those who have not applied earlier

## \*\* ONLY FOR DIRECT ENTRY CANDIDATS AS NO LATERAL ENTRY SEATS WIL BE AVAILABLE THIS YEAR FOR 03 GOVT MCHS


After opening of BMLT/BMRT Courses in 03 State Govt Medical Colleges and Hospitals (viz; SCB MCH, Cuttack / MKCG MCH, Berhampur / VIMSAR, Burla), the Combined Counseling Committee has decided to open the Registration window for Fresh New Applicants and Edit Window for Existing Applicants, those who are interested to apply for BMLT / BMRT courses for the academic session 2025-2026.

Accordingly, aspirant candidates are divided in 04 distinct categories.

- (A) Candidates who have neither registered nor applied earlier and are going to apply for the first time
- (B) Candidates, who have already applied earlier to any other courses after 10+2 Eligibility, but not applied to BMLT / BMRT Courses and have a valid application number
- (C) Candidates, who have already applied earlier to the courses after 10+2 Eligibility, and applied to any one of the BMLT / BMRT Courses and have a valid application number
- (D) Candidates, who have already applied earlier to the courses after 10+2 Eligibility, and applied to both BMLT and BMRT Courses and have a valid application number

## Instructions:-

- (A) Candidates who have neither registered nor applied earlier and are going to apply for the first time are advised to register themselves by clicking the Link Preliminary Registration and then can proceed for Online Application (can go through the document instruction manual for online application) and can Finally submit the online application to generate a valid application number. No application will be valid, if not submitted finally and without generating a valid application number.
- (B) Candidates, who have already applied earlier to any other courses after 10+2 Eligibility, but not applied to BMLT / BMRT Courses and have a valid application number – Candidates, if applied earlier to any courses after 10+2 eligibility, having a valid application number generated, but not applied to either BMLT or BMRT courses, can apply to any one of the course or both the courses by logging to the counseling system by entering their user ID and Password.



- (C) Candidates, who have already applied earlier to the courses after 10+2 Eligibility, and applied to any one of the BMLT / BMRT Courses and have a valid application number If any candidate has applied earlier having a valid application number and applied either any one of the BMLT or BMRT course, and now planning to apply the other course from BMLT / BMRT which he /she has not applied earlier, can apply by the above method.
- (D) Candidates, who have already applied earlier to the courses after 10+2 Eligibility, and applied to both BMLT and BMRT Courses and have a valid application number in such scenario, they need not to do anything as they have already having a valid application number and also a valid Common Meri Rank in BMLT and BMRT Course.
