COMMON INSTRUCTIONS HOW TO APPLY ONLINE TO PARTICIPATE IN ONLINE COUNSELING PROCESS

Payment of Fees :-

- 1. The Candidate need to pay first before filling the online application. The payment link is given in website separately.
- 2. the payment can be made by using Debit Cards / Credit Cards/ Internet Banking / IMPS / Mobile wallets / Cash Cards etc as different options enabled by State bank of India payment gateway.
- 3. On successful completion of the transaction, an e-receipt will be generated. Keep one print outs with you for future reference.
- 4. Non generation of e-Receipt indicates payment failure. On failure of payment, candidates are advised to chk their payment status by clicking payment history.
- 5. To ensure the security of your data, please close the browser window once your transactions and online applications are completed.
- 6. Don't save your user ID and Password in the browser. Basically, if you are using any common platform / internet connections, be sure that, you clear all cookies and browsing history after your application / any activities. As in most cases, cookies as well as browser history are saved automatically in that system and can be activated automatically to the next person who uses the same website and data migration will happen. And if, at any circumstances, such situation persists, the Counseling committee will not held responsible.

Guidelines for Scanning and Uploading documents like Photo and Signature:-

Passport Photograph :

- 1. Before applying online, a candidate will be required to have a scanned (digital) image of his/her photograph and signature.
- 2. The photograph must be a recent passport size colour picture.
- 3. Make sure that, the picture is in colour, taken against a light coloured, preferably white background.
- 4. Look straight at the camera with a relaxed face.
- 5. If you wear glasses, make sure that, there were no reflections and your eyes can be clearly seen.
- 6. Caps / hats / dark glasses are not acceptable. Religious headwear is allowed but should not cover the face.
- 7. The dimension / resolution of the photograph should be 200 x 230 pixels. (Or)
- 8. Height x Width of the image should be 4.5 cm x 3.5 cm.
- 9. Size of the Photograph should be between 30-50 kb.
- 10. Ensure that, the size of the scanned photograph is not more than 50 kb. If the size is more than 50 kb, then adjust the settings of the scanner such as DPI resolution , no of colours etc. during the process of scanning.
- 11. File type should be .jpg / .jpeg
- 12. Don't use Mobile scanner in this purpose.

Full Signature :

- 1. The applicant has to sign on a white paper with Black pen ink.
- 2. Dimensions should be 140 x 60 pixel. (or)
- 3. Height x Width of the image should be 1.5 cm x 3.5 cm.
- 4. Size of the image should be between 10-20 kb.

- 13. Ensure that, the size of the scanned image is not more than 20 kb. If the size is more than 20 kb, then adjust the settings of the scanner such as DPI resolution, no of colours etc. during the process of scanning.
- 5. File type should be .jpg / .jpeg
- 6. Don't use Mobile scanner in this purpose.

Scanning the Documents :-

- 1. Set the scanner resolution to a minimum of 200 dpi (dots per inch).
- 2. Set the colour to true Colour.
- 3. File size as specified above.
- 4. Crop the image in the scanner to the edge of the photograph / signature, then use the upload editor to crop the image to the final size as specified.
- 5. Don't upload the whole scanning of the full page, just crop it to the specific Photo/Signature.
- 6. The image file should be .jpg/ .jpeg format. Rename the images in your name as AishwaryaPhoto and Aishwaryasign.
- 7. Candidates using MS Windows or MS Office picture manager, scanned documents in any format can be saved in .jpg/.jpeg formats by using "Save as" option in the file menu. Size can be adjusted by using crop menu and then resize option.

Procedure for uploading the Documents :-

- 1. While filling the online application, there is a section called. Upload photo / Signature.
- 2. Click on the respective buttons "Upload Photo" / "upload Signature"
- 3. Browse and select the location where the scanned Photograph / Signature is saved.
- 4. Select the file by clicking on it.
- 5. Click the "Open / Upload"
- 6. If the file size and format are not as per the guideline, after uploading Photo / Signature, in the final application same will not be previewed.
- 7. Candidate should ensure that, photo is uploaded at the place of photo and signature in place of signature.
- 8. If , at any case, the Photo and Signature are interchanged, then the application will be out rightly rejected. Be cautious of this.

Clarifications regarding EWS quota :-

 Persons, who are not covered under the existing scheme of reservation to the Scheduled Caste, Scheduled Tribe, and Socially and educationally Backward Classes and whose family Gross income is below Rs.8.00 Lakh (subject to any amendments from time to time), are to be identified as EWS or as per the guidelines issued by Govt. and EWS certificates issued to concerned candidate from time to time.

Common Instructions: -

Preliminary Registration Page :-

- The Candidate need to register first for online application (one time only), choose the button "Click here for New Registration"
- 2. This is the page called as "Preliminary Registration"

- 3. You have to select, whether you are a resident of Odisha means having a valid resident Certificate issued from Tehsildar or Not
- 4. Select if you have passed out from any Govt. Medical/Dental Colleges situated in Odisha or Not.
- 5. Select the year in which you want to participate for Counselling
- 6. Enter your correct NEET Roll Number
- 7. Enter your Date of Birth as you have mentioned in NEET application (Select from the Calender shown) after clicking on the entry box (if the calender is not seen, then it might have some problem in your browser, and change the browser or install Java scripts to activate the calender control/ java script, or change the system.)
- 8. After entering the NEET ID and Date of Birth, please wait few seconds, your NEET Score and Name will be automatically shown in respective sections as per your NEET record.
- 9. Enter your valid e-mail address and re-type your e-mail address for confirmation.

Basic Information Page:

- After completion of the Preliminary Registration (after clicking of the link Register and Proceed for Online Application), you will be redirected to the next page control panel #Dashboard where in the left side you can see 5 options (#Dashboard, #Basic Information, # Service Particulars, #Preview Application, # Logout), and after clicking #Basic Information, # Service Particulars, #Preview Application, you will be redirected to the respective sections. But by clicking the # Logout link, you will be Logged out from the system.
- 2. Automatically, you will be redirected step by step once you will go on filling up desired information step by step.
- 3. You can view the information entered by you, only after successfully completion of each phase. Which can be edited any time before final submission of the data.
- 4. In the right hand panel, you can see, a welcome message in your name with showing the registered e-mail address and mentioning the status of your application.
- 5. The above welcome message will be scrolled in Red colour until the application is finally submitted.
- 6. Once the application is finally submitted, the welcome message scrolled in Red colour will be turned to Blue/Green, and the left side #Basic Information, # Service Particulars, #Preview Application links will be deactivated.

- 7. Write the Name of the Institution, where you have deployed under the column Name of the Institution.
- 8. Then Select / Choose the drop down from the areas list shown as per the prospectus / annexure / appendix is concerned.
- If the area under which you were posted is not in the list of drop down areas, please recheck the name in the list available in the prospectus / annexure / appendix, and if not available, select "Others".

- 10. Then pick / chose the Date of Joining in that head quarter and select / pick up the date from the calendar control.
- 11. 18. Like the above Service particulars enter, you can enter the leave details, if you have any.

- 19. In case of Leave particulars details, levaes taken under maternity leave will not be taken in to consideration and these duration of these leave periods will be shown as zero days.
- 20. Like this, leave taken other than maternity leave like EL /CL etc, will be calculated , if the leave exceeds more than 30 days.

21. Like the above service particulars, leave can be added or edited by deleting one by one the last records followed by one by one record till the record you want to be edited / corrected.

Automatic Calculation of Total days of Service:

- 1. After filling up Service Particulars as well as Leave particulars, automatically the No of total days of Service will be calculated by adding all days of Service durations in number of days.
- 2. Like the service particulars, total number of leave days will be calculated automatically.
- 3. In the same manner, total number of days worked in weightage areas will be calculated automatically.
