GUIDELINES FOR COUNSELLING AND ADMISSION OF CANDIDATES FOR POST-GRADUATE (DENTAL) COURSES IN SCB DENTAL COLLEGE, CUTTACK ODISHA

The terms and conditions of this guidelines will remain valid until further orders subject to condition that Govt. reserves the right to change any of the clause/s as per need as & when required. The DMET (O) is authorized to change the constitution of committee, schedule dates or any other changes as per requirement with intimation to Govt.

The seats shall be filled up by online counselling.

A. Counselling & Admission Committee & its function :-

Selection of candidates for PG (Dental) Courses in S.C.B. Dental College& Hospital, Cuttack affiliated to Utkal University of Odisha shall be conducted by the Counseling and Admission Committee and shall consist of :

(The constitution of the above committee shall be changed every year by the DMET, Odisha under intimation to Govt. The Convener shall be on rotation basis from Govt. Dental Colleges of state having PG course. The selection process shall be centrally regulated by Education Cell under DMET Odisha)

Functions:

When required the representatives of the Dean & Principals can attend the meeting duly authorized by them. All the meetings shall be done in online virtual mode, in electronic media like zoom, google meet etc. as per convenience.

1. The **Chairman** will be the controlling & supervising authority and must see that the counselling and admission are done in strict conformity with the rules laid down and notify the tentative dates.
 - a. He will ensure expenditures as per Govt approved rates for the purpose and will release funds in time for smooth counselling and admission.
 - b. A dedicated Cell with provision of logistics like computer, printers, scanners, internet, mobile with sim, stationeries shall be ensured for smooth work.

- c. A separate Bank account in State Bank of India shall be opened with link to SBI Collect. It is to be operated jointly by Chairman and Convener. All the sale proceeds (application / counselling fees collected from candidates) for the selection process shall be deposited in the same account. All the expenditures shall be met from the sale proceeds. In no case the expenditures shall exceed the total amount collected by such sale proceeds. The balance amount of sale proceeds shall be returned to DMET, Odisha, for deposit in "Entrance Examination Fee" account. An advanced money shall be released to the Chairman at the beginning of process by DMET (Odisha) from the Entrance Examination Fees account, if requested for.
2. The **Convener** on behalf of the Committee will carry out the following works & take the approval of the Committee from time to time.
 - a. Collect the detail State Quota seats for the current academic year from the Dean & Principals of SCB Dental College and prepare the seat matrix for counselling.
 - b. Collect the list of NEET MDS qualified candidates of Odisha along with their marks secured from the Govt. of India.
 - c. Prepare the inter-se merit list of candidates by awarding additional weightage of marks to the in-service candidates, as per the provisions contained in Clause-H.
 - d. The Convener is authorized to file affidavits in legal matters on behalf of the Chairman, Counselling Committee, and Govt., float advertisements, convene meetings, and conduct counselling/allotment/admission strictly as per the guidelines. She/ He is the custodian of all documents including vouchers of expenditure of counseling process and will produce as and when required with in the weeding out period.
 - e. The Convener shall select the agency for online counselling.
 - f. For smooth management a PG Selection subcommittee shall be formed taking the faculties. Where required one Group C employee, one DEO and one Group D employee can be engaged on daily wage basis for day to day management of the selection work. Such wages shall be met from the counseling fees. Additional technical and support staff shall be engaged by the chairman as per need basis.

B. COMMENCEMENT OF SESSION:

The academic session commences from 1st May of the academic year unless otherwise notified.

C. DURATION OF THE COURSE:

1. The PG (Dental) Courses are of 3 years duration from the date of joining.

2. Admissions to PG (Dental) Courses are subjected to starting / renewal of permission/ increase of seats by the Ministry of Health & Family Welfare, Govt. of India. In case of any shortfall of three years of tenure, the candidate has to repeat the course for the shortfall period.
3. The courses of study and the registration of candidates for post-graduate study at the respective colleges in the subjects concerned will be regulated by the University to which the Medical College is affiliated.

D. DISTRUBUTION OF SEATS:

The seats will be distributed between In-service and Direct candidates of state on 50:50 basis. (As per the direction of Hon'ble Apex Court passed in WP(C) No. 196 of 2018 Dt. 31.08.2020.

The unfilled All India Seats if surrendered to the State will be available for counselling and the reservation percentage will be maintained as per the Clause The detail state quota seats and their distribution will be notified at the time of counseling.

Candidates who have discontinued P.G. (Dental) or are continuing such courses can participate the counseling after deposition of the monetary penalty as per these guidelines and bond conditions.

NB: The discrepancies in distribution of seats under direct, in-service, and reservation will be made good on rotation basis.

E. RESERVATION OF SEATS:

The reservation percentage for both Direct and In-service category will be 67% for UR category, 12% for ST category, 8% for SC category, 5% for PH and 5 % for Green Card (GC) category and 3% for Ex-Servicemen (Ex-S) category. The subjects in which seats are increased under EWS quota shall be available to EWS candidates only. Such EWS seats if remain unfilled shall be filled by General category students.

Percentage of reservation will be maintained as far as practicable taking the total seats, college wise seats, subject wise seats i.e. pre-clinical, para-clinical and clinical seats in to consideration subject to condition that, any discrepancy due to odd number will be made good in subsequent years on rotation basis.

There shall be no reservation in management quota seats in private colleges and shall belong to UR category only.

Candidates qualified in NEET-MDS under OBC non-creamy layer central list category shall be eligible to participate but shall be included in UR and respective categories in merit list.

Note 1: Scheduled Caste/Scheduled Tribe persons who have migrated from their State of Origin to some of her State for the purpose of seeking education, employment etc. Will be deemed to be scheduled Caste/Tribe of the State of their Origin and will

get privilege from the State of origin and not from the State to which they have migrated. (Vide Govt. of India Letter No.BC/16014/1/82-SC&BCD/Dated:22nd February 1985).

Note2: Seats reserved for S.T. and S.C. candidates are to be filled up by the applicants belonging to the respective community as per the Odisha Caste Certificate (for S.C. and S.T.) Rules–1980 and as amended from time to time by Government of Odisha and are not interchangeable.

Note 3: The seats reserved for P.H Category will be filled-up by the persons with bench mark disabilities in accordance with the provisions of the Rights of persons with Disabilities Act, 2016, based on the merit list of National Eligibility-cum-Entrance Test for admission to P.G Medical courses, as per list appended to this guideline or as may be amended from time to time.

Note 4: Candidates claiming under Green Card category must produce the Green Card in original of their parents, and must not have taken the privilege of reservation using the same card before. The facts & figures mentioned in the Green Card must tally with other relevant certificates submitted. In case of any discrepancy the claim under Green card reservation will not be considered. However he/she will be treated under unreserved category.

Note 5: To be eligible for reservation under Ex-servicemen category, the candidate must be:

(a) A Permanent Resident of Odisha

(b) Son/daughter/spouse of a person who was in defense service OR the candidate himself/ herself has served in defense service.

(Ex-servicemen mean persons who worked in Army / Navy / Air Force and who come under the definition of Ex-servicemen in vogue at the time of their discharge / retirement).

Such candidates must produce certificate from Rajya Sainik Board, Bhubaneswar, Odisha, regarding their eligibility under Ex-servicemen category. Candidates who themselves or their parents are continuing in defense service at the time of application are not eligible for reservation under this category.

Note 6: To be eligible for reservation under EWS category, the candidate must full fil:

(a) Candidate's annual family income must be less than Rs. 8 lakhs per annum.

(b) His family must not own more than 5 acres of agricultural land.

(c) The residential flat area should be below 1000 sq ft.

(d) The residential plot's area should be below 100 square yards if in a notified municipality sector.

(e) The residential plot's area should be below 200 square yards if in a non-notified municipality sector

F. ELIGIBILITY:

1. At the time of application the candidate must have passed B.D.S. degree examination from an institution recognized by Dental Council of India fulfilling all criteria laid down by Dental Council of India as eligibility / qualifying criteria and has obtained registration either from the Dental Council of India or any of the State Dental Council after passing the final B.D.S. Examination and have already completed / completing one year (12 months) **Compulsory Rotating Internship** in a recognized Dental College by **31st March, of current year or as may be notified by appropriate authority** and must be:
2. A permanent resident of Odisha and required to furnish a certificate of permanent residence of Odisha from a Revenue Officer not below the rank of Tahasildar of the area concerned

OR

3. The Son/Daughter/Spouse of any one of the following category
 - i. Employees of Government of Odisha
 - ii. All India Services belonging to Odisha Cadre serving within or outside Odisha
 - iii. Public Sector undertaking of either State of Odisha or Govt. of India located in Odisha
 - iv. Ex-servicemen personnel who is a permanent resident of Odisha (shall produce the relevant Certificate from Rajya Sainik Board).
4. Candidates who have completed PG (Dental) Course or studying PG (Dental) in any subject shall not be eligible to apply for PG (Dental) Course.

G. CATEGORY OF CANDIDATES:

1. A **Direct Candidate** is one who at the time of application is either unemployed or in the employment of Government of Odisha/Public Sector Undertakings of Govt. of Odisha or Govt. of India located in Odisha, but not completed three years of service which includes all categories of employment like contractual/ temporary / ad-hoc/ regular by **31st MAR of current academic year.**

Is son/daughter/ spouse of a person who has served in Defence Service and stationed in Odisha for minimum of 5 years by **31st MAR of current academic year.**

The employer has to sponsor the candidates for entire period of course & must submit the sponsorship certificate as in **Appendix II.**

2. An **In-service** candidate is one who at the time of application:

Is under employment in Government of Odisha/ Public Sector Undertakings of Govt. of Odisha or Govt. of India located in Odisha and has completed a length of three years of service which includes all categories of employment like contractual/ temporary / ad-hoc/ regular by **31st MAR of current academic year**, excluding at a stretch leave of any kind of 30 days or more. However the maternity leave is exempted from this exclusion and shall be counted towards the length of three years of service.

Note: The candidates in employment under Government of Odisha/ PSU, are advised to apply with intimation to their Employer. Copy of such intimation is to be submitted.

H. ADDITIONAL WEIGHTAGE

1. The additional weightage will be awarded to in-service category candidates vide section G.2.supra and shall be calculated for the number of days actually worked in institutions in remote/ vulnerable areas till the 31st March of the current year of admission at the following rates subject to maximum of 30% of marks secured to be added to the NEET-MDS score of the candidate while determining the merit.
 - a. Candidates who are working prior to dt.21.03.2016 shall be awarded additional weightage @ 10% marks per year as per provisions of Govt. vide Notification No. ME-II-M-02/2015-5750/H/ dt.21.03.2016 vide Annexure A (enclosed)
 - b. Candidates who have joined service after dt.21.03.2016 shall be awarded additional weightage @ 2.5%, 5%, 7.5% & 10% marks per year in V1, V2, V3 & V4 areas respectively vide Annexure B (enclosed).
2. Maternity leave period availed if any shall be eligible for calculation of additional weightage
3. Candidates applying for diploma course shall not be awarded any additional weightage while drawing their merit list.

I. ONLINE COUNSELING:

1. The schedule of counseling shall be as per direction of MCC / Hon'ble Supreme Court issued from time to time.
2. In compliance to order dtd.16-12-2021 in Special Leave to Appeal (C) No.10487/2021 before the Honourable Supreme Court of India, there shall be four rounds of counselling in the state. First and Second round shall be

conducted in online mode to be followed by the Mop up and Stray vacancy rounds to be conducted in physical mode. All the rounds may be conducted online in exigency as per decision of the selection committee.

3. All the merit listed candidates who wish to participate in counselling procedure for admission must register in due time in the website of DMET, i.e. www.dmetodisha.gov.in in appropriate admission sections. Registration means creating own username and password for logging in to the online counselling site. Without registration the candidate cannot proceed to next step of online application. The username and password must not be shared with others.
4. After log-in to the site the candidate has to fill up the online application form and submit by clicking the “submit” button. A print out of the online application form must be taken.
5. The candidate has to attend the document verification session done in virtual/ physical mode and get his/her online application authenticated or as may be notified. In case of emergency any authorized person on behalf of the candidate can attend physical document verification on production of authorization letter of candidate. The candidate has to deposit the counselling / application fees, of Rs.2500/- in SB Collect, i.e. https://www.onlinesbi.com/sbcollect/lcollect_home.htm and self-attested copies of documents along with originals. The counselling /application fee is not refundable. Only on successful verification of documents and after online grievance redressal the candidate becomes eligible and name will appear in the merit list. The names of candidates who fail to attend document verification on scheduled dates will not appear in the merit list and cannot participate in choice lock and subsequent process of counselling and admission. Any alternate method of document verification if followed shall be notified by the convener.

6. There shall be no fresh registration allowed for further rounds of the state counselling except when there is revision in the qualifying cut off score in NEET-PG by appropriate authorities.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and admission will be cancelled as the case may be and disciplinary / legal action as deemed proper will be initiated against him/ her. Besides the same candidate will not be allowed to participate in the admission process in next three academic years.

7. Then the candidate has to submit his/her choice of course and college (any number) in order of preference as per schedule, in the online site and lock the choice.
8. College and course will be allotted on merit and choice basis. The candidate can download the allotment-cum-admission letter and personally appear before the Convenor on the notified date, time and venue along with required admission fees for provisional admission. The mode of deposit of admission fees will be notified by Convenor. The candidate has to deposit the original College Leaving Certificate/Transfer Certificate as the case may be and will be issued a provisional admission letter. In case of emergency situations, the online mode of admission shall be done and will be notified.
9. The candidate must report before the authority of the institution allotted within stipulated date as notified and submit a copy of the provisional admission letter for completion of admission process at institutional level.
10. Candidates admitted in the first round against clear vacancy shall be upgraded against any vacancy resulted in, for non reporting of candidates in first round.

The resulting vacancy arising out of such upgradation shall be added to the vacancy for the second round.

Allotment during second round will be done for the available vacant seats and virtual vacancy that may arise due to change of earlier admitted seat.

The resulting vacancy arising after second round shall be added to the vacancy for the mop up round.

- 11.** No candidate shall be allowed to resign from the admitted seat of second round in the state to take part in All India Counselling and admission. Candidates admitted and holding a seat at the end of second round counseling either in All-India seats or State Quota seats shall not be allowed to participate in the subsequent All India quota / State quota counselling and admission.
- 12.** Candidates can surrender a seat as per the guidelines followed by MCC or direction of Hon'ble Supreme Court from time to time. In such cases they shall get back 90% of the admission fees deposited and 10% shall be retained as processing fees
- 13.** If the candidate resigns any time after the completion of mop up round or fails to complete formal physical reporting at the college within the stipulated time, it will be considered as resignation after admission but before course completion and action as mentioned hereinafter vide clause-J below shall be initiated against the candidate.
- 14.** The process of Mop Up Counselling shall be as under:
 - 14.1.** The CLC in original and the admission fees are mandatory failing which, no admission will be given and the next candidate in merit will be admitted. The details regarding deposit of admission fees shall be notified by the Convener in due time.

- 14.2. The order of counselling in Mop Up Round of counselling shall be Scheduled Tribe (ST)–Scheduled Caste (SC)–Physically Challenged (PC/PwD/PH)–Ex-Servicemen (ES)–Green Card (GC)–EWS–General (GEN). There shall be no interconvertibility between ST and SC category.
- 14.3. Unfilled seats in reserve category shall be filled up by UR candidates. Unfilled seats in in-service category shall be filled up by Direct category candidates.
- 14.4. The sequence of mop up round counselling shall be as follows;
In-service reserved seats ~ in-service UR seats (including unfilled seats of in-service reserved category) ~ direct-reserved (including unfilled in-service-reserved seats after in-service UR category counselling) ~ direct UR category (including unfilled direct-reserved and unfilled in-service UR category seats).
- 14.5. Candidates once admitted in a seat in mop up round is final and are not allowed to change the seat/subject in the same mop up counselling. Candidates once admitted can leave the seat by submitting resignation to concerned Dean & Principal. Such seat shall be included in the counselling process only after receiving such information from the Dean & Principal.
- 14.6. Candidate can participate only during the slot where he/she is called to exercise choice as per the merit rank.
- 14.7. Candidates reporting late in the mop up or stray vacancy round counselling will be allotted seat from available seats at that point of time. They cannot claim a seat which is already allotted.
- 14.8. Counselling for Diploma seats shall be conducted after counselling for MD/MS seats are over during Mop up Round. No candidate shall be allowed surrender/resign from admitted MD/MS seats to participate in diploma counselling during Mop up round.
- 14.9. The Allotment-cum-Admission-Letter shall be issued to the applicant on the spot during the Mop up counselling.

- 15.** The process of Stray Vacancy Round counselling shall be as under:
- 15.1. The stray vacancy round shall be conducted in physical mode for any unfilled seats at the end of mop up round.
 - 15.2. All the unfilled seats in in-service and direct category shall get converted to general category for counselling. The stray vacancy round counselling for admission into the unfilled seats in the private colleges (both state and management quota) shall be conducted at concerned college level under the supervision, instructions and guidance of the selection committee. A composite report thereof shall be submitted to the convenor in time.
 - 15.3. There shall not be any fresh registration allowed for this round except when the cut off score is lowered.
 - 15.4. Candidates in the state merit list who have not joined in any AIQ or State quota seat shall be eligible to participate in the stray round.
 - 15.5. No candidate shall be allowed to resign/surrender from any admitted seat during stray vacancy round.
 - 15.6. The sequence of counselling shall be as follows;
In-service general seats ~~ Direct-general seats (including unfilled in-service general category seats) ~~ Diploma general seats.
 - 15.7. The reporting candidates shall be allowed to participate in order of merit to exercise choices, provisional admission shall be completed on the spot only on submission of CLC and the admission fees with issue of Allotment-cum-Admission-Letter by the convenor. The CLC and the admission fees are mandatory failing which, no admission will be given and the next candidate in merit will be admitted. The details regarding deposit of admission fees shall be notified by the Convenor in due time.
- 16.** Other detail procedures & schedules of different rounds of counselling, choice locking, schedule of provisional admission & reporting etc. will be notified by the Convenor in the website of DMET, Odisha in appropriate section as and when required. Candidates are requested to be in constant touch with the website.

I. ALLOTMENT OF SEATS:

1. Allotment will be made strictly on the basis of merit list of state prepared by Convener and as per the choice of subject & college locked by the candidate. Allotted candidates shall be provisionally admitted in the Convener's office by depositing the allotment letter, Bond, CLC and required fees.
2. In-case of non-availability of any reserved candidates; such unfilled seats will be filled up by unreserved candidates. No inter-changeability between ST & SC seats is allowed.
3. Unfilled "All India Seats" if any, will be filled up as per the decision of the selection committee on the spot of counseling.
4. While preparing merit lists, in case of two or more candidates securing equal marks the ranking shall be decided in order of preference as under:
 - a. Candidate securing higher marks in the subject applied for in his B.D.S. Examination.
 - b. If this is equal, the elder, according to the date of birth furnished, will get preference over the younger

J. ADMISSION AND JOINING

1. The Candidates have to submit the allotment cum admission letter before the Principal SCB Dental College & Hospital, Cuttack for maintenance of records and completion of admission procedure.
2. If a candidate after taking admission in the allotted seat resigns due to any reasons before the completion of the course, he/she has to pay a sum of Rs. 10,00,000/- (Rupees ten lakh) as a financial penalty along with the amount of stipend/salary received by him/her till the date of resignation, in shape of Bank Draft drawn in favour of "Entrance Examination Fees, DMET, Odisha" payable at HOD Building Branch Bhubaneswar. The candidates have to submit an undertaking to that effect and the original documents /CLC will not be returned to the candidate until the penalty is realized. The entire admission fees deposited will also be not refunded.
3. Candidates selected for PG course shall submit the bond in prescribed format duly signed by the candidate and sureties at the time of provisional admission. Such format of Bond is available in the website of DMET, Odisha.

K. FEE STRUCTURE:

A candidate selected for admission shall have to deposit the following fees payable at the time of admission.

(In addition, University Fees as applicable will be collected in respective colleges)

The courses of study and the registration of candidates for PG (Dental) study will be regulated by the Utkal University.

The Medical Fitness Certificate (**Appendix No. III**) must be produced by the candidate at the time of joining.

L. ATTENDANCE AND LEAVES

1. PG Students are to perform the duties as assigned to them by the Professor concerned and to attend required theory and practical classes and departmental seminars regularly.
2. PG Students are entitled to avail 15 days leave during each year of study with the permission of the Head of the Institution, but such leave should not exceed 10 days at a stretch. This restriction does not hold good in case of candidates availing Maternity leave. All the candidates have to repeat the exact number of days of leave taken in excess of 15 days after which they will be issued completion certificate.
3. Absence beyond the total period of 15 days without prior permission of the Professor & Head of the concerned Department and Dean & Principal of the College concerned shall be seriously viewed and the candidate may forfeit the right to continue. However on extraneous circumstances the period of absence beyond 15 days may be condoned by DMET, Odisha with proper justification. The said condonation period will not be repeated by the candidate.

4. All candidates on joining the PG Course shall work full time during the period of training attending not less than 80% of the training during each calendar year. Private practice of any kind is strictly prohibited. Anyone found to be indulged in such activities will be seriously viewed and legal action as deemed proper will be initiated against him.

M. SALARY AND STIPEND

1. PG Students admitted against direct quota seats and not completed five years of service but taken admission in in-service category, will be paid stipend at rates prescribed by the Government of Odisha from time to time subject to satisfactory performance of duties and maintenance of discipline and decorum.
2. The period of PG study and salary of PG Students under employment of Government of Odisha (who have completed five years of regular service) will be governed by the existing Govt. principles or any instruction as would be issued from time to time.
3. The in-service candidates of PSUs shall be paid salary by their respective appointing authority as per Annexure III. However if they are denied of salary due to any reason stipend at the rate fixed by Govt. from time to time shall be allowed. The candidates have to obtain NOC from their employer to the effect at the time of admission.

N. HOSTEL

1. Hostel accommodation being limited, cannot be guaranteed for all and allotment of seats in the Hostel will be made by the Principal of the S.C.B. Medical College, Cuttack to the needy and deserving students according to availability of seats.
2. Fees to be paid for hostel accommodation:

The following fees are to be deposited in the respective Govt. Institution after the admission is final at the end of counselling.

P. MISCELLANEOUS

1. If any candidate discontinues PG studies in the midst of the academic session for any reason, he/she will have to pay monetary penalty of Rs. 10Lakh .
2. If the candidate discontinues PG studies for any reason, what so ever, at any stage after admission, he/she shall be liable to refund the entire amount of stipend / leave salary, pay and allowances, etc. actually paid to him/ her during the period of his / her studies.
3. All PG (Dental) Degree holders, who are offered jobs by the Government, but donot opt to join the same shall be liable to refund the leave salary / pay and allowances / stipends actually paid to him/her during the period of study along with other such disciplinary action as the Government may decide.
4. Without prejudice to the conditions stipulated for submission of application/ selection/ admission in the foregoing paragraphs of this prospectus, a candidate who is having drug addiction or has been convicted for any criminal offence shall not be selected / admitted even though he / she may have been eligible for selection / admission under the provision of this prospectus. Concealment / misrepresentation about drug addiction and criminal conviction shall be liable for disqualification.
5. A selected candidate shall be required to produce all original documents and deposit the same, if required, including the Original College leaving Certificate at the time of counseling. He / She has to appear before a Medical Board (s) constituted for the purpose to decide his / her Medical Fitness.
6. In all matters relating to eligibility or otherwise of a candidate for registration, sitting in entrance examination, selection and admission into PG courses, the decision of selection committee shall be final.
7. All admissions are subject to verification of the original documents as well as production of Medical Fitness Certificate in the form as in **Appendix – III.**
8. **Any addendum or corrigendum if required shall be notified by DMET Odisha in the website which will be a part of these guidelines and shall be binding.**

Self-attested photocopy of the following documents should be submitted during document verification):

1. Certificate of Board of Secondary Education / Matriculation / 10th Class Pass Certificate or equivalent in support of the Date of Birth of the Candidate.
2. B.D.S. Degree or Provisional B.D.S. Pass Certificate issued by the concerned University.
3. Completion / Continuation Certificate of Compulsory Rotatory Internship / Housemanship, issued by the Principal / Superintendent of the Dental College & Hospital concerned by 31st March, 2020.
4. Permanent Dental Registration Certificate State / Central Dental Council of India.
5. Three attested recent color photographs of size 40x50 mm (one to be pasted on Medical Certificate (**Appendix – III**)).
6. Certificate from competent authorities in support of eligibility criteria claimed under Clause 5 (Necessary documents may be furnished in support of the claim made by the applicant in Appendix I, II, as applicable).
7. In-Service candidates who have rendered the required length of service as per Clause 6.2.1 must submit a certificate from the concerned CDM&PHO.(s) or appropriate authorities in support of his / her claim stating therein chronologically the place of posting, duration of service including Contractual, Temporary, Ad-hoc and Regular postings, the respective places and the Block and the District to which the place belongs (as per **Appendix – I**). Leave period exceeding 30 (thirty) days at a stretch shall not be counted towards the length of service.
