INSTRUCTIONS FOR STATE ROUND – 3 (MOP-UP) COUNSELLING OF PG (DENTAL) – 2023-24

1. As per the Supreme Court of India and Odisha PG Dental Guidelines – 2023-24, there will be 4 rounds of Counselling.
2. The Round – 1 and Round – 2 of State Counselling is already over.
3. The State Round – 3 will be treated as Mop-Up Round.
4. The State Round – 3 (Mop-Up) will be conducted on Physical Mode and Candidates need to present Physically at the time of counselling to exercise their choices.
5. At the time of State Round – 3 (Mop-Up) counselling, candidate who will opt for fresh exercising of choices (not admitted in state in earlier rounds), need to keep original CLC and admission fees ready at the time of their turn, else the next candidate will be given the opportunity.
6. Before State Round – 3 (Mop-Up), if MCC reduces the qualifying score of minimum eligibility, fresh applications will be invited and the Counselling will be made basing on the new revised merit list.
7. In State Round – 3 (Mop-Up), once a candidate is getting admitted provisionally, in no way, he/she will be permitted to resign that seat, and if anyone want to do so, it will be treated as resignation after counselling is over / commencement of the course and will come under the Penalty Clause of the State Guideline.
8. Any candidate, who holds a seat at the end of Round – 3 of All India Counselling are not eligible to participate in the State Round – 3 (Mop-Up).
9. The procedure of the State PG (Dental) Counselling for Round – 3 (Mop-Up):
The net vacant seat due to Non-Allotted, Non-Joining, Non-Reporting of Round – 2 will be published in the Seat Matrix and eligible candidates will be allowed to participate.
10. The following categories of candidates **are eligible** for State Round – 3 (Mop-Up) of PG (Dental) Counselling – 2023-24.
 - a. Candidates who are in State Merit List but with or without any allotted seat in State Quota Round – 1 and Round – 2.
 - b. Candidates who have joined a seat in Round – 1 and Round – 2 of State Quota want to upgrade his / her seat.
 - c. Candidates who resigned in State Quota by end of Round – 2, but not allotted a seat in Round – 3 All India Quota
11. Who **will not be eligible** for State Round – 3 (Mop-Up) of PG (Dental) Counselling
Candidates who have joined seat in Round – 1, Round – 2 and allotted seat in Round – 3 All India Quota (as per the data shared by the MCC) are not eligible to participate in Round – 3 State PG (Dental) Counselling – 2023-24.
