ADDENDUM

Consequent upon the approval for starting DNB, Post DIPLOMA DNB & Post MBBS DIPLOMA courses in the State, National Board of Examinations in Medical Science, Govt. of India vide Letter Reference No. NBEMS/EDO/2025/426 Dt.14.08.2025, has accredited certain Govt. Hospitals in the State of Odisha for DNB / Diploma courses for admission w.e.f. 2025 session. Hence to have smooth counselling and admission in to these courses the following **ADDENDUM** will be incorporated in the Post-Graduate (Medical) Selection Odisha Guidelines for Counselling and Admission of candidates for Post-Graduate (Medical) & Post-MBBS NBEMS Diploma courses in Govt. and Private Medical Colleges of the State 2025-26;

1. The existing guidelines will be named as: POST-GRADUATE (MEDICAL), POST MBBS DNB / POST DIPLOMA DNB & POST-MBBS NBEMS DIPLOMA COURSES IN GOVT. AND PRIVATE MEDICAL COLLEGES OF THE STATE 2025-26.
2. In Clause C, point 5) is added as follows. The duration of POST MBBS DNB course shall be of three-year duration whereas the POST DIPLOMA DNB and POST MBBS DIPLOMA shall be of two years duration.
3. In Clause D, the following shall be added. The DNB and the DIPLOMA course seats are only for regular in-service candidates through OPSC. The number of seats available will be as per the decision and recommendation by NBEMS communicated from time to time. In all courses 50% of seats will be for All India Quota and rest 50% will be for State Quota in In-service category. The details of seats available will be notified by the Convener in seat matrix.
4. In Clause E, Reservation of seats will be applicable for DNB / DIPLOMA
5. In Clause G, a sub clause 4 is added as follows- The candidate applying for Post MBBS DNB must be under employment in regular service (OPSC) and must have completed 3 years of such regular service by 31st Mar of Current year of admission excluding at a stretch leave of any kind of 30 days or more. However the maternity leave is exempted from this exclusion and shall be counted towards the length of 3 years of service.
6. In Clause I, in the Online Counselling the following shall be added.
 - a. The counselling for admission to Post Diploma DNB seats will be conducted & completed prior to start of counselling for NEET PG (including Post MBBS DNB / Post MBBS Diploma Seats) of the same admission session.
 - b. Once the counselling for Post Diploma DNB seats is completed, all the vacant/ unfilled Post Diploma DNB seats of a hospital in that particular speciality will be converted to the pool of corresponding Post MBBS DNB seats for that particular admission session. "For example, if an accredited department has 3 post MBBS DNB + 3 Post Diploma DNB seats and only 1 Post

Diploma DNB seat was filled then total 5 Post MBBS DNB seats will be included in the NEET PG Counselling of that admission session".

7. In Clause K -4, the fee structure for post DIPLOMA DNB / post MBBS DNB and the post MBBS Diploma shall be as decided by the NBEMS from time to time. The fees of Hitech Medical College, Rourkela and Bhubaneswar has been revised and will be applicable. The revised fees is available in the website of DMET Odisha.
8. In Clause M, Salary and stipend the words PG/Diploma shall be replaced by PG/DNB/DIPLOMA. In point M-3, The period of PG//DNB/Diploma study of candidates who have completed 5 years' service under regular employment of Government of Odisha (not on ad-hoc or contractual basis) admitted in to PG/DNB/DIPLOMA Courses shall be governed as per the existing service rules and executive instructions thereon.
9. In Clause M, a point 6) shall be added as follows. All the decisions relating to the Post DIPLOMA DNB / Post MBBS DNB / Post MBBS DIPLOMA shall be guided by the NBEMS.

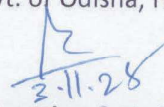
