***The above schedule is strictly provisional and subject to change depending upon the submission of data of allotted candidates in Stray vacancy Round of All India.**

NB:1. The in-service candidates have to report physically at their respective college on or before 28.02.2026, without fail. They have to join at their respective Department/College after being relieved from their concerned authorities.

2. Candidates are required to bring **Bank Draft** of the exact amount admission fees (as mentioned in Annexure-1) drawn in favour of "**PG MCC ODISHA 2025**" payable at SCB Medical College Campus, Cuttack Branch. Candidates opting for admission in private medical colleges either shall submit DD for exact amount or shall make split amount of DD as required or shall submit a DD for the highest applicable fees, whichever is suitable.

3. No cash payment/online payment is accepted during the slot of the candidate.

4. Original CLC and Admission fees are mandatory, failing which no admission will be given and the next candidate in merit will be admitted.

5. Candidates reporting late will be allotted seat from available seats at that point of time. They cannot claim a seat which is already allotted.

6. Physical presence of the candidate is mandatory during Stray Vacancy counseling. No authorization will be accepted.

7. If a candidate fails to submit bank draft for the admission fees during his/her slot period, next candidate in merit will be called for admission.


